Day Camp Evaluation

Day Camp is a cage-free service designed for social dogs to play and have fun. Safety is our primary goal, therefore, **Day Camp is not for every dog.** It is not a place for aggressive dogs to learn how to be social. To be accepted into our Day Camp program, each potential Day Camp guest must:

1. Complete the Guest Profile and Evaluation Check-In
2. Be at least 12 weeks of age and have completed their full series of vaccinations, including the bordetella vaccine.
3. Meet our vaccination and temperament standards
4. Be spayed or neutered (except puppies under 6 months)
5. Attend a day camp evaluation day and be deemed "safe for play."

Overnight guests wishing to attend Day Camp must be accepted prior to first day of stay. Clients are strongly encouraged to make reservations for their dogs to attend Day Camp. Day Camp is limited in size, so please book ahead to avoid disappointment. Priority goes to clients with standing reservations. We request 24-hour notification for cancellations in order to properly staff a safe play environment.

To properly evaluate your dog and to give them a chance to settle in comfortably, we require that your dog stay with us for 2 hours on their first day.

Dog Boarding and Dog Daycare Policies and Release of Liability

THIS AGREEMENT is entered by and between Paws Chateau, and dog owner

Please Read & Initial Each Item:

- 1) _____ I (Owner) represent that I am the legal owner of the above-named dog(s) and I assume all risks, dangers, and responsibility for injuries to the named dog(s). Owner understands and agrees that Owner is solely responsible for any harm while Owner's dog(s) is/are attending Daycare / Boarding.
- 2) _____ GROUP PLAY: All dogs must pass a general behavior assessment to attend dog-to-dog group play. No dog may be admitted to group play who show any signs of any type of aggression. Owner further understands and agrees that in admitting Owner's dog(s) to dog-dog group play, Owner is representing to Paws Chateau that Owner's dog(s) is/are in good health and have not harmed, shown aggression, or exhibited any threatening behavior towards any person or other dogs. Any dog demonstrating aggression or other behavior deemed unacceptable by Paws Chateau staff may be required to leave daycare/boarding.
- 3) _____ RELEASE OF LIABILITY: Owner understands and agrees that during normal dog play, Owner's dog may sustain injuries. Dog play is monitored by Paws Chateau staff to best avoid injury, but scratches, punctures, torn ligaments, and other injuries may occur despite the best supervision. Owner further understands and agrees that neither daycare/boarding nor any of its employees or staff will be liable for any illness, injury, death, and/or escape of Owner's dog(s) provided that reasonable care and precautions are followed, and Owner hereby releases Paws Chateau staff of any liability of any kind whatsoever arising from or as a result of Owner's dog(s) attending Paws Chateau.
- 4) _____ PERSONAL PROPERTY: Owner understands that Owner is solely responsible for any harm, including to any other pet(s), to the employees Paws Chateau or to the equipment, facilities, or other property of Paws Chateau, caused by Owners dog(s). Owner also agrees that Paws Chateau shall not be responsible or liable for any lost or damaged personal property belonging either to Owner or Owner's pet.
- 5) _____ FOOD/MEDS when boarding overnight, Owner agrees that it is the Owner's responsibility to leave adequate supply of food and medications for Owner's dog(s) during the entire time Owner's dog is cared for by Paws Chateau. Should the food/medication supply need replacement, Owner authorizes Paws Chateau to purchase replacement and Owner will reimburse Paws Chateau for the actual food and medication costs plus up to \$25.00 time/distance trip fee (per occurrence).
- 6) _____ PREPAID PACKAGES: Owner understands that prepaid daycare packages are nonrefundable and expire 3 months from date of purchase.
- 7) _____ PAYMENTS are due and payable at the end of each visit. Payment may be made in American currency, Visa, Discover, or Master Card. \$25 NSF charge for returned checks. CANCELLATION / NO-SHOW POLICY: Cancellations must be done 48-hours prior to reservation date. If cancellation notice is less than 48-hours an amount of two nights stay will be invoiced.
- 8) _____ CLOSING TIME: Owner agrees that if Owner's dog(s) is/are not picked up by closing time, then Owner hereby authorizes overnight boarding appropriate for dog(s) and to pay Paws Chateau for applicable overnight boarding charge plus any charge for required food.
- 9) _____ RIGHT OF REFUSAL: Paws Chateau reserves the right to refuse admittance to any dog or dismiss any dog that does not meet or maintain the health, temperament or other daycare/boarding standards. The determination shall be made at the sole discretion of Paws Chateau.

- 10) _____ DOG'S HEALTH: Owner understands and agrees that Owner's dog(s) are healthy and will always while attending Paws Chateau have current vaccinations for rabies, distemper and Bordetella. Owner is not enrolling any dog that has any condition that could potentially jeopardize the health of other dogs or people and has not had any potentially communicable condition within 30 days prior to enrollment. Owner further understands that even if Owner(s) dog is vaccinated for Bordetella (Canine Cough) there is a chance that the Owner's dog can still contract Canine Cough. Owner agrees that Owner will not hold Paws Chateau responsible if Owner's dog(s) contracts Canine Cough or other dog-to-dog transmitted ailments.
- 11) Canine Cough
_____ I understand that Canine Cough is a highly contagious upper respiratory viral infection that is primarily passed from one dog to another through direct contact but also passes through aerosol droplets in the air.
_____ I understand that there are many different types of Canine Cough some of which are not covered by vaccines.
_____ I understand my dog/s are at a risk of contracting Canine Cough when bringing them into any type of Social environment where other dogs are or have been recently including but not limited to Vet's Office's, Parks, Beaches, Boarding Facilities & Training Facilities.
_____ I understand that older dogs and puppies have a higher risk of contracting Canine Cough.
_____ I understand if my dog/s contacts Canine Cough I will notify Paws Chateau and will not bring them back to daycare until they are fully clear of any symptoms.
_____ I understand that if my dog/s does get Canine Cough that Paws Chateau will not be responsible for vet bills or other costs associated.
- 12) _____ FLEA/TICK FREE: All dogs must be flea/tick free. Should a dog be observed to have fleas or ticks, a flea/tick bath treatment will be applied and charged to the owner at a rate of up to \$80.00 depending on severity and size of dog.
- 13) _____ WEAKENED IMMUNE SYSTEM: Owner understands special-needs dogs, young puppies, and senior dogs naturally have a higher risk of injury, stress-related illnesses, weakened immune system, or exacerbation of any pre-existing condition. As such, by using our facility for daycare or boarding the Owner is waiving any claim for injury or illness experienced by Owner's dog while in our care.
- 14) _____ ELDERLY DOGS: Owners of elderly dogs (approaching the end of life) need to know if in the event Owner's dog passes on while in our care, our policy is to transport Owner's dog to our on-call vet where he/she will be held until Owner can be reached by the Vet for further instructions.
- 15) _____ VETERINARIAN LIABILITY AND CARE: Owner agrees that Paws Chateau can obtain medical treatment for Owner's dog(s) if he/she appears ill, injured, or exhibits any other behavior that would reasonably suggest that dog(s) may need medical treatment including anesthesia. Owner agrees to be fully responsible for the cost of any such medical treatment and for the cost of any transportation for the purposes of such treatment. Owner gives permission to Paws Chateau to use their on-call Vet (Beach City Animal Hospital) or nearest 24-hour vet hospital for required treatment.
- 16) _____ FULL FORCE AND EFFECT: Owner further understands and expressly agrees that each and every of the foregoing provisions contained in paragraphs 1-15 shall be in force and effect and shall apply to each and every occasion on which Owner's dog(s) stays with Paws Chateau for daycare, extended boarding, or other services, as the case may be. This Agreement shall remain in full force and effect as between the parties until and unless otherwise cancelled or superseded in writing by both parties.

Owner hereby certifies that Owner has read and understands this Waiver and Release of Liability and the regulations set forth above. By signing this agreement, Owner agrees to be bound by its terms and conditions.
