

Day Camp Evaluation

Day Camp is a cage-free service designed for social dogs to play and have fun. Safety is our primary goal, therefore, <u>Day Camp is not for every dog.</u> It is not a place for aggressive dogs to learn how to be social. To be accepted into our Day Camp program, each potential Day Camp guest must:

- 1. Complete the Guest Profile and Evaluation Check-In
- 2. Be at least 12 weeks of age and have completed their full series of vaccinations, including the bordetella vaccine.
- 3. Meet our vaccination and temperament standards
- 4. Be spayed or neutered (except puppies under 6 months)
- 5. Attend a day camp evaluation day and be deemed "safe for play."

Overnight guests wishing to attend Day Camp must be accepted prior to first day of stay. Clients are strongly encouraged to make reservations for their dogs to attend Day Camp. Day Camp is limited in size, so please book ahead to avoid disappointment. Priority goes to clients with standing reservations. We request 24-hour notification for cancellations in order to properly staff a safe play environment.

To properly evaluate your dog and to give them a chance to settle in comfortably, we require that your dog stay with us for 2 hours on their first day.

Dog Boarding and Dog Daycare Policies and Release of Liability

THIS AGREEMENT is entered by and between Paws Chateau, and dog owner Dog(s) name / Breed(s)_____ Please Read & Initial Each Item: 1) _____I (Owner) represent that I am the legal owner of the above-named dog(s) and I assume all risks, dangers, and responsibility for injuries to the named dog(s). Owner understands and agrees that Owner is solely responsible for any harm while Owner's dog(s) is/are attending Daycare / Boarding. GROUP PLAY: All dogs must pass a general behavior assessment to attend dog-to-dog group play. No dog may be admitted to group play who show any signs of any type of aggression. Owner further understands and agrees that in admitting Owner's dog(s) to dog-dog group play, Owner is representing to Paws Chateau that Owner's dog(s) is/are in good health and have not harmed, shown aggression, or exhibited any threatening behavior towards any person or other dogs. Any dog demonstrating aggression or other behavior deemed unacceptable by Paws Chateau staff may be required to leave daycare/boarding. RELEASE OF LIABILITY: Owner understands and agrees that during normal dog play, Owner's dog may sustain injuries. Dog play is monitored by Paws Chateau staff to best avoid injury, but scratches, punctures, torn ligaments, and other injuries may occur despite the best supervision. Owner further understands and agrees that neither daycare/boarding nor any of its employees or staff will be liable for any illness, injury, death, and/or escape of Owner's dog(s) provided that reasonable care and precautions are followed, and Owner hereby releases Paws Chateau staff of any liability of any kind whatsoever arising from or as a result of Owner's dog(s) attending Paws Chateau. 4) PERSONAL PROPERTY: Owner understands that Owner is solely responsible for any harm, including to any other pet(s), to the employees Paws Chateau or to the equipment, facilities, or other property of Paws Chateau, caused by Owners dog(s). Owner also agrees that Paws Chateau shall not be responsible or liable for any lost or damaged personal property belonging either to Owner or Owner's pet. 5) FOOD/MEDS when boarding overnight, Owner agrees that it is the Owner's responsibility to leave adequate supply of food and medications for Owner's dog(s) during the entire time Owner's dog is cared for by Paws Chateau. Should the food/medication supply need replacement, Owner authorizes Paws Chateau to purchase replacement and Owner will reimburse Paws Chateau for the actual food and medication costs plus up to \$25.00 time/distance trip fee (per occurrence). 6) PREPAID PACKAGES: Owner understands that prepaid daycare packages are nonrefundable and expire 3 months from date of purchase. PAYMENTS are due and payable at the end of each visit. Payment may be made in American currency, Visa, 7) Discover, or Master Card. \$25 NSF charge for returned checks. CANCELLATION / NO-SHOW POLICY: Cancellations must be done 48-hours prior to reservation date. If cancellation notice is less than 48-hours an amount of two nights stay will be invoiced. _CLOSING TIME: Owner agrees that if Owner's dog(s) is/are not picked up by closing time, then Owner hereby authorizes overnight boarding appropriate for dog(s) and to pay Paws Chateau for applicable overnight boarding charge plus any charge for required food. RIGHT OF REFUSAL: Paws Chateau reserves the right to refuse admittance to any dog or dismiss any dog that does not meet or maintain the health, temperament or other daycare/boarding standards. The determination shall

be made at the sole discretion of Paws Chateau.
